1. Resolution No. PQ-5117 dated May 19, 2021 of the President of the Republic of Uzbekistan "On measures to bring the activity of popularizing the study of foreign languages to a qualitatively new level in the Republic of Uzbekistan":

In accordance with paragraph 1, under the Cabinet of Ministers of the Republic of Uzbekistan, the positions of the Agency for Popularization of Foreign Language Learning (hereinafter referred to as the Agency) and the positions of regional representatives of the Agency in the Republic of Karakalpakstan, regions and the city of Tashkent;

In accordance with paragraph 2, the Agency and its representatives are 34 state units of the republican scientific-practical center for the development of innovative methods of teaching Shet languages under the State University of World Languages of Uzbekistan, the Ministry of Public Education and the Ministry of Higher and Secondary Special Education. the information that the system was established at the expense of 39 state units should be accepted.

2. Establish such a procedure that the Agency:

coordinates the activities of state bodies and organizations, local executive authorities, and state educational institutions on the popularization of foreign language teaching;

establishes relations with foreign and local partners and arranges to attract their financial, organizational and methodological support to popularize the study of foreign languages in the country;

together with the ministries and agencies, develops and implements methodologies that enable civil servants to perform their professional activities in foreign languages;

determines comprehensive measures to popularize the study of at least ten foreign languages in high demand;

develops qualification requirements and assessment criteria for foreign language teachers and organizes the process of assigning them a qualification category based on the principle of mutuality;

The Quality Control of Education under the Cabinet of Ministers, together with the State Inspection, confirms the list of internationally recognized certificates assessing the level of knowledge of foreign languages and the correspondence between the levels of national and internationally recognized certificates determining the level of knowledge of foreign languages.

3. Termination of the activities of the republican scientific-practical center for the development of innovative methods of teaching Shet languages under the Uzbekistan State University of World Languages of the Ministry of Higher and Secondary Special Education of the Republic of Uzbekistan (hereinafter referred to as the Center) to agree to his proposal.

Note that:

The agency is to develop and continuously improve the entire continuous education system of the Center in accordance with international standards of state education standards, curricula and programs, educational and educational-methodical manuals in all foreign languages. is considered the legal successor in terms of living contracts, rights and obligations, and economic contracts;

In order to digitize the teaching of foreign languages and widely introduce modern information and communication technologies in the field:

a) online training courses for young people in foreign languages should be launched in the IT-centers of the regions, and a part of these costs should be covered by the Youth Fund in accordance with the law.

The Ministry of Information Technologies and Communications Development of the Republic of Uzbekistan should approve the plan of measures for the organization of online training courses involving foreign specialists in IT centers within two months;

b) the licensing procedures of educational organizations organizing the educational process on the basis of distance (online) teaching technologies should be simplified, taking into account the following:

reviewing the conditions of the educational organization regarding educational tools and setting special requirements regarding distance (online) teaching technologies;

organization of the educational process on the basis of recognized foreign and international standards, formation of legal bases;

taking into account the possibility of conducting the educational process remotely (online) through automated programs and video courses;

to create an opportunity to involve persons with practical skills as well as pedagogical staff in the education process in certain areas, including information and communication technologies.

Licensing of activities of educational organizations organizing the educational process on the basis of distance (online) technologies of teaching within two months by the State Inspection of Education Quality Control under the Cabinet of Ministers, the Ministry of Information Technologies and Communications Development of the Republic of Uzbekistan and the Ministry of Justice submit a draft decision on revising the procedures.

CONCLUSION

Within the framework of the implementation of the Law of the Republic of Uzbekistan "On Education" and the national personnel training program in the country, a comprehensive system of teaching foreign languages, that is, a harmoniously matured, educated, modern-minded young generation a system
